# **STEM Workforce Development**

MHTA's goal is to ensure a well-educated STEM workforce to meet the current and future demands of the state's science and technology employers. A key component of this is ensuring that we retain talented students here in Minnesota after they receive their associate, undergraduate and graduate degrees. To help prepare our next generation of STEM talent, MHTA is requesting:

• \$3.46 million over FY2020-21 for the **SciTechsperience Internship Program**, to provide at least 825 STEM internships over the next two years.

# **Science and Technology Infrastructure**

MHTA's goal is to strengthen Minnesota's science and technology ecosystem through funding for research and development activities and financing for entrepreneurs. That's why MHTA is requesting funding, policy changes and the establishment of a new program to support and encourage these initiatives. **MHTA's request includes**:

- Reinstate the Angel Investment tax credit to \$20 million/year to encourage investment in Minnesota-based science and technology startups.
- Establish a state-funded matching grant program for recipients of awards from the federal Small Business Innovation Research (SBIR) or Small Business Technology Transfer (STTR) programs.
- Establish an elective state **alternative simplified R&D tax credit** of six percent on all qualified research expenses for the taxable year above the base amount.

# **Cybersecurity**

MHTA's goal is to grow Minnesota's software industry and protect unwanted access of digital assets. An important aspect of protecting digital assets is sharing information. The ability for policymakers and others to share confidential or sensitive information is crucial, especially in time-sensitive or security-related incidents—ensuring the Legislature has in place the structure to gather the appropriate information is crucial to its ability to make informed decisions on a complex, sensitive topic like cybersecurity. **That's why MHTA recommends establishing a**:

- **Legislative cybersecurity commission** to develop legislation to support and strengthen Minnesota's cybersecurity infrastructure.
- **Cybersecurity task force**, composed of cybersecurity professionals from the private sector, government and academia, to make policy recommendations to the governor for how to strengthen Minnesota's cybersecurity infrastructure.

# **Broadband and Telecommunications**

MHTA's goal is to expand the availability and use of broadband technology to access new markets, enhance educational access, improve quality of life, and provide Minnesota citizens and businesses the capabilities necessary to compete in a dynamic, global marketplace. **MHTA's recommendations include**:

- Support the **recommendations of the Governor's Task Force on Broadband** to expand access to broadband throughout Minnesota.
- **Uphold Minnesota's existing Internet privacy statutes and regulations** and encourage any clarification or refinement of statues and regulations pertaining to the Internet to occur at the federal level.

# **STEM Higher Education**

Ensuring that Minnesota's institutions of higher education are well-funded and able to provide a cutting edge, quality education is critical to helping Minnesota maintain its competitive advantage. That's why MHTA supports funding requests from the University of Minnesota and Minnesota State. In particular, MHTA supports the following 2019 budget requests:

# • <u>University of Minnesota</u>

 \$87 million increase in funding over base budget (part of which supports research and technology infrastructure).

#### Minnesota State

- \$37 million to support ISRS Next Gen, a mission-critical, multi-year technology infrastructure project to replace our out-of-date enterprise technology system and substantially improve the student experience.
- \$15 million to address the workforce gap through innovative career, technical and professional programming serving business and industry.



# **Public Policy Principles**

The Minnesota High Tech Association (MHTA) advocates for public policy that strengthens Minnesota's technology-based economy and positions Minnesota as a global leader through the development and use of advanced technologies.

MHTA develops, supports and advocates for policies that promote the long-term growth, sustainability and global competitiveness of Minnesota's technology-based economy.

MHTA believes that strong, consistent, focused leadership from the private sector, working in collaboration with academic, nonprofit and government partners, is the critical link in driving our state's development and recognition as a global technology leader.



# SciTechsperience Internship Program

- Our goal of placing 390 interns before August 31 is still within reach; we are at 372 hires as of Wednesday, June 12. This is the highest number of interns the program has ever placed, and 4 hires ahead of 2018.
- Thanks to the heroic efforts of John Dukich, Doug Carnival and Joe Bagnoli during the 2019 Legislative session, the SciTechsperience program managed to secure \$1.75 million for the 2020-2019 SFY. While this is substantially less than the \$3 million we requested, we were fortunate to secure any funding at all. The House version of the Jobs and Energy omnibus bill had no direct appropriation while the Senate version included SciTech at \$3 million. During the final negotiations of the omnibus Jobs bill, the House and Senate met a little over half way, thanks to the unwavering support of Senator Eric Pratt. Thanks to all involved in this effort.
- What does this mean for the future of SciTechsperience?
  - 1) The number of wage matches available over the next two years is 400, or 200 matches per year. This is a nearly 40% decrease compared to the current biennium, which called for at least 650 placements (we're actually at 740 as of today).
  - 2) The wage match remains at up to \$2,500 per intern. Our request had included moving the match up to \$3,000 per intern, but that had to be scrapped when the overall allocation was reduced.
  - 3) We are undertaking an immediate assessment of other funding options to augment the state funding. Many options are being considered.
- We have begun planning our summer site visits. The focus will be on visiting companies we haven't been to before. Stay tuned for more on this.

MNSBIR has strong collaborative relationships with the University of Minnesota, Mayo Clinic, Office of Entrepreneurship, and other research institutions to support research, technology transfer and commercialization.

The principal goal of the Biotechnology Initiative for Innovation, Collaboration and Entrepreneurship (ICE)

Translational Research Grant Program is to foster entrepreneurship in College of Biological Sciences (CBS) faculty-driven approaches to solving issues critical to society. ICE seeks to recognize and enhance biotechnology research opportunities by awarding grants for field-shaping research in new and emerging areas. This is best accomplished by identification of postdoctoral fellows and research associates; whose goal is to become entrepreneurs in a new business enterprise (NewCo) they (possibly with other collaborators) seek to establish and grow.

#### **OPERATIONS & FINANCIAL**

May financials are complete. Adjusted net income is \$199,903K vs a budget of \$252,168K running \$52K behind budget. Included in expenses is \$18K that was unbudgeted for the President's search, which puts net income at \$34K behind plan. Membership income is behind plan by \$52k. Spring conference came in below income, but was 8K above budgeted net due to expenses running under plan. Scitech and SBIR mainly running to plan, with a few timing differences. Most expenses running close to plan, with some administrative costs being slightly over, and staffing being slightly under plan. Overall budgeted expenses are \$33K under budget.

The 2018 audit and 990 drafts are complete. The 2018 audit went very well, with no adjustments and a clean opinion. The auditors will present the 2018 audit and 990 form to the Executive Committee for approval, and then the 990 will be sent to the full Board for review.
